Brief summary of the proposed change.

Fact of life change to allow certain types of telemetry because built in telemetry is now a part of many radio systems. This change would still prohibit use of any telemetry that gives a competitive advantage to the pilot. The change is urgent because pilots at the 2013 Nats could be protested and disqualified if using certain radio equipment.

Exact wording proposed for the rule book. (List paragraph numbers where applicable. Example: Change "quote present rule book wording" to "exact wording required".

#### Change:

"4.4: Equipment Functions. Radio control equipment shall be of the open loop type (i.e. no electronic feedback from the model to the ground). Auto pilot control utilizing inertia, light, gravity, or any other type of terrestrial reference is prohibited. Automatic control sequencing (preprogramming) or automatic control timing devices are prohibited."

#### And Change 4.4 8)

"8) Electronic or other signal or feedback from the model of any kind. "

#### To read:

"4.4: Equipment functions. Any telemetry or other types of radio feedback to the pilot or the caller such as airspeed, position, GPS coordinates, motor rpm, etc, are prohibited during competition. Telemetry that does not give a competitive advantage to the pilot, such as receiver battery voltage warnings, radio interference, radio malfunctions, etc, is permitted. Telemetry data shall not be used as a basis to request a re-flight. Auto pilot control utilizing inertia, light, gravity, or any other type of terrestrial reference is prohibited. Automatic control sequencing (preprogramming) or automatic control timing devices are prohibited. A proven competitive advantage to the pilot will result in the loss of that round."

#### And 4.4 8) to read:

Logic behind proposed change, including alleged shortcomings of the present rules. State intent for future reference.

More radio systems are coming out with basic telemetry built in, and the inability to turn it off in certain cases. As an example, if someone showed up at the NATS with a Hitec Aurora 9 or a Futaba 12sg, they are technically illegal radios since you cannot turn off telemetry of the receiver voltage back to the transmitter. If a protest was lodged, the flyer could be disqualified. That wasn't the intent of the original rule. This change allows for certain forms of airplane fault telemetry that is built in to newer radio systems, while disallowing advanced telemetry that could give a competitive advantage to the pilot.

Discussion: A discussion was held concerning the appropriate amount of funding the NSRCA should grant to the FAI teams. Should the NSRCA contribute equal funds to the F3A team and to the F3P team? The NSRCA has a long history of supporting the F3A World team. We remain committed to that effort and we fully recognize that F3A is currently where the bulk of our member's interest lies. F3P is a new but growing discipline within pattern. Funding for F3P is a special circumstance due to this being the first F3P World Championship team that is representing the USA. At this point in time, if we authorize this additional \$2000 for the F3P team, we will be funding the F3A and the F3P teams at the same rate. This does not commit the NSRCA to continue this level of funding for F3P in the future. The NSRCA is the AMA recognized SIG for F3P and we are in bootstrap/startup mode for this discipline. All of this contributes to the uniqueness of this particular F3P World Team effort.

F3P style flying is more prevalent in northern locals because of the winter flying season and indoor flying is better suited. The southern DVP's expressed concern because there is little to no indoor flying in southern states. It was also noted that even with proper funding, each member of the F3P team will incur about \$600 individual out of pocket expenses for the World Championships. However, each member of the F3A team will spend approximately \$5000 out of pocket expenses.

Discussion (Jon Carter): Every two years the FAI CIAM board meets to discuss and vote on new rules for FAI. Two years ago we authorized our representative (Derek Koopowitz) to attend. Due to poor weather and other issues he was unable to go. The meetings are again coming up and as you can

see from the attached email from Derek we will need to allocate some funds to send him. The good news is he still has the credit from the last ticket! All we need to cover is the price difference and the hotel and meals. So, based on Derek's estimate, we need to approve roughly \$710 to cover this trip. There are FAI rules that will be discussed that I believe we should have our representative there (both for the discussion and the vote).

(Derek Koopowitz) - "The good news is that because I did not use that ticket 2 years ago due to the weather issues and me being unable to travel, I still have the \$1100 (I don't remember the exact price for the ticket) but prices have gone up and I believe the cost of the ticket is around \$1300 now. I will need authorization from the board to go ahead with this travel which will include hotel costs for 3 nights plus meal expenses - I'm guessing the total will be around \$130+ per night in a hotel and around \$40 a day for meal expenses. Estimate is \$510 for room/board and then another \$200 for the air ticket."

"I get my marching orders from the NSRCA and also from the F3A pilot community... the AMA has no directive on what we do - they can offer input. They rely on my input to vote - I actually don't get to vote at the meeting, only the AMA rep. does (Bob Brown). He can choose to change his vote if he disagrees with me but I haven't seen that happen yet."

Motion: To accept this version of the cross proposal 16-7. The new cross proposal will read as follows: 6.x At no time will a model be left unrestrained or unattended while running or with the electric motor power circuit(s) physically connected unless the model is on the runway. If maintenance or testing needs to be done and the model must be running or have the electric motor power circuit(s) physically connected, this must be done in an area designated by the CD, be physically restrained, and must be attended at all times. First infraction of this rule will result in a warning. Second infraction will result in loss of the highest round. Subsequent infractions will result in loss of the highest round remaining and, at the CD's discretion, up to disqualification of the pilot.

Discussion: There was discussion to change the wording unrestrained or unattended to:
unrestrained and unattended. (Scott McHarg) It is as written with "or". The word "and" does not work in this situation. The model cannot be left unrestrained or unattended which means both. If you put "and" in there, you are saying you cannot both be unrestrained and unattended. "Or "specifies both in this case. There is no motion for an amendment based on "and" which completely defeats the intention.

This increases the cost of printing and mailing charges. Another consideration could be a 1/4 page ad but I think the 1/2 page is good. The person that sent in their ad was willing to pay the \$130 for a 1/2 page ad for one month. If we do 1/4 page, do we make considerations for other sizes? Personally, I think it gets too complex creating all the different scenarios. \$50 is cheap and we can all come up with 1/2 page ads to promote our contests.

The NSRCA currently maintains 4 accounts with Wells Fargo business banking:

Our operating account (Checking)
Our savings account (earning .0312% interest)
The F3A world team operating account
The F3P world team operating account

Our operating account and the debit card associated with it along with electronic statements has a monthly fee of \$12, waived because our balance exceeds \$10,000, but also incurs a \$2 monthly fee (not waived) for having check images available to us in our statement and a \$10 (also not waived) for having a debit card. Hence we pay \$12/month for our operating account.

Our savings account has a monthly fee of \$6 which is waived due to the balance we maintain

- The F3P World team operating account has a \$14 monthly fee associated with it (opened more recently) which, despite being linked with our other accounts which have a combined balance in excess of \$40,000 is NOT waived.
- The F3A World team operating account has a \$14 monthly fee associated with it, which IS linked and IS waived because we've put it in a separate "category" which makes it very difficult to transfer funds raised through team activities but billed through our merchant account and therefore deposited to our operating account.
- In short, between the 4 accounts we pay \$26/month and we earn .0312% interest on our savings account.
- Further, using online banking and online check deposit with Wells Fargo I am limited to depositing \$3500/month and \$800/day using their applications. Any time we have checks amounting to more than \$800 or \$3500/month I have to visit a Wells Fargo branch to make the deposit. This is possible, but inconvenient and sometimes delays deposits by several days. We see checks in excess of that amount in July (advertiser receipts) and in January, as well as, occasionally in December.
- Prompted by the customer focus (their key measure of success is net promoter score, which I'll be happy to explain if anyone asks) I decided to investigate the business banking options from Capital One.

Business checking is 100% FREE. No minimum balances, no debit card fees.

Business savings has an introductory interest rate of 1% for one year and after that drops to the standard rate which is currently 0.4%

Making this change would save the NSRCA \$168/year and the world teams \$168/year. Further, assuming we maintained our current savings balance (and did not move more money into savings, which, I would actually recommend that we do to maintain an operating balance of about \$20k in the bank and \$5k in PayPal) we would earn \$73.21 in interest (vs \$2.28 from Wells Fargo)

In summary, shifting the status quo from Wells Fargo to Capital One would improve our operating finances by \$238.93 for the NSRCA and \$168 for the world teams in the first year. In subsequent years (again, assuming status quo) we would improve the NSRCA operating finances by \$197.60 using current interest rates and \$168 for the world teams.

Discussion:

- [Secretary] It is a recommendation, and not set in stone. We still have the option to use other scoring systems.
- [D1] What does this recommendation really do for us? Rereading the email about our mission statement where does this fit? I have gotten feedback from D1 members that they feel it is rather arrogant to keep promoting an expensive scoring system when we can barely get anyone to contests.
- [Vice President] This all came about because I made a statement about the NSRCA needing to "officially" embrace a system if we were going to recommend something to the E.D. of the AMA NATS. I also made the statement that I felt we needed to see how the authors of the other software felt about selecting one or the other prior to endorsing a system.
- With all due respect to all parties and with Gordon's input, I have an issue with all of this and feel that, while the system makes judging better, there is pressure from individuals to accept a system that is produced by members of both the NSRCA BoD as well as the AMA Contest Board. I do not believe that the purpose is to make a profit however. I'm really having a hard time with this, especially when we haven't tested the "complete system" at a NATS and we are more than willing to dive head first for the 2016 NATS which is a US TEAM SELECTION YEAR instead of taking a more methodical approach and trying the system on one Site or maybe two. What's the rush? In the computer world, if you change more than one variable, you never know what the actual fix was.
- [President] I really see no problem with the NSRCA "recommending" a scoring methodology. If a better method of doing something comes up, what is the problem with recommending it? We are not requiring it and we are investing (through the grant program) in improving pattern scoring nationwide, which is probably the single most contentious and bitched about item in pattern. I think this is in our wheelhouse so to speak and if we did not push for it nationwide we would be derelict in our duty. I really fail to see any arrogance here, we are just working to promote and improve pattern, kind of what we are supposed to be doing.
- [D3] In terms of utilizing the scribe at the Nats, I have recommended it for the Masters Finals and FAI Semi-Finals and Finals. These portions of the Nats provide a "contained" test bed and are also the most visible and can definitely benefit the most from the significant improvement that the scribe system brings. The final decision is AL Glenn's [2016 NATS ED] however.
- We all really need to get on board with the scoring system. It's a huge leap forward in our sport. \$2500 (\$2000 to the folks in your district), is extremely affordable for what you get. At a lightly attended contest, that's the price of a prop. It's not a big ask for such a big gain.
- Promoting the idea to the constituents in your district that the system is not worth the investment is counterproductive to our hobby. Sticking with handwritten scores is about equivalent to flying a Heathkit radio in a Dirty Birdy with a muffled K&B.61 and trying to make the FAI finals at the Nats.
- [D6] Why are we promoting this system, so it can be mentioned in the NATS recommendation to the ED

- and used because some perceive current NATS scoring as biased and can be manipulated.
- This is all because no one knows how NATS scoring is run, and how it really is double checked and can be verified that no foul play occurred.
- This is because the NSRCA won't stand up and speak for the process we had that was fine.
- All that is needed is duplicate score sheets for the pilot and scoring. Problem solved.
- AND... This is an FAI problem only at NATS.
- [D3] Perhaps we should chat more as a group discussion, but the reason I'm so excited about the system has nothing to do with bias. It's simply a better way to do things. It is automating the grunt work of a contest, and it's a completely transparent system. You see scores and results almost immediately after a pilot lands. I truly believe that once everyone has an opportunity to use it once or twice, you'll be as vocal as I am with support.
- I'm not hung up on which scoring program to use. I suspect that an app can be written to make the system work with any of the scoring programs. If the true concern is a proprietary venture, perhaps some other folks would be interested in spending the time to develop their own app version that can work on the hardware that Peter assembled.
- That said, I feel that is an incredible waste of effort to have multiple scoring programs out there. It's not a complicated procedure. You add up the numbers, multiply the K factor, and normalize it out. Let's put this creative energy to work on making the master scoring system the best solution possible from a technological and user experience.
- [Treasurer] MasterScoring has been the system of record for use at the NATS for at least 4 years now. There is no change from that perspective.
- I completely rewrote Gordon's app (which is in now unsupported and very fragile VB6 embedded in excel) for the original implementation of the scribe. Before that I ran several contests with scoring on Gordon's program. I don't think I've seen a contest happen that didn't have at least two crashes of the VB code in Gordon's app that required a complete restart. People who aren't technically savvy can get themselves into real trouble on Gordon's app as evidenced by an AZ contest that didn't have final results until 3 days after the contest because of data loss/crashes. It's a huge support burden for Gordon.
- My rewrite worked reasonably well, but still had to occasional issue in score reporting that required minor manual intervention in the spreadsheet formulas.
- Fundamentally, neither solves for the NATS scale contest, there is zero support for Matrix scoring or anything beyond a small local contest. There is also no support for TBL and neither would ever be certified for use by the FAI for an FAI national or continental contests.
- MasterScoring is an extremely robust program, I've personally scored at least 25 contests with it and have never seen even one incident of data loss or corruption. It does have to very occasional error (i.e., not observed from one judge and no scores from the other judge will cause an exception) but it catches those Exceptions and provides the user with a support path to get the problem resolved.
- The other option, PACSS, I have no personal experience with other than some 2 year old conversations with Gene about making the scribe work with it too. It is written in COBOL, has no facilities for importing or exporting scores and, since the platform/language for which it was written is not

supported on modern Windows platforms, does not have much life left in it.

Last year, I made the decision to focus my scribe efforts on making it work really well with MasterScoring because I saw that as the best use of my time.

Fundamentally, I have put my effort into the scribe system for three simple reasons:

- 1. I think it improves scoring. If you don't believe me, look at the scores of the OCMA contest a few weeks back. Despite every admitted attempt by a certain known-biased judge to tank the scores of a certain rival sandbagging in Masters, scoring by deductions seen meant that the best (sandbagging) pilot got the best scores from all judges. That would not have happened with paper--people remember what they wrote down and can bias from it.
- 2. As a scorekeeper, I missed being able to interact with people at the contest. Flying a flight literally put me 30 minutes behind in score entry. Even with due care I usually had at least one incorrect entry that was caught by the pilot per contest (20 contestants = 4520 opportunities to make a mistake). I don't think I ever scored a contest in 2 years of manually entering scores without a least 5 N/O's from judges because they were looking at a score sheet instead of a plane.
- 3. The sheer waste of time at a contest as contestants lost their score sheets between rounds or forgot to pick them up from the scoring table, fighting wind-blown papers for contestants, judges, and scorekeepers, stapling tear sheets to score sheets, etc. Between MasterScoring and the scribe we are typically handing out awards within 5 minutes of the last pilot landing.
- Do I want the system used at the NATS? Sure, but only because I see it solves a number of problems and perceived problems.

Do I care if we 'endorse' one system for use at local contests? No.

- Do I think the system is 'ready' for the NATS? Yes, for any contest portion run in traditional fashion (Advanced, Intermediate, Masters finals, FAI semis and Finals). No for a contest run with Matrix because there is a built-in assumption of one system running the scores for both sites. Until Scott and I come up with a good way to 'merge' data from two sites running the same contest but different parts of the matrix I'm not ready to declare support in the scribe for the Matrix system.
- The scribe has been run for 2.5 seasons (at least 13 contests each season), 1.25 completely in MasterScoring. There has been no loss of data in that time, and only one instance of incorrect data getting into master scoring which was caught and corrected though use of the redundant logs on the scoring devices.
- I toured the country with it at my own expense last year (with the exception of the Chicago contest where Steve and Bobby were kind enough to cover my travel expenses) to give as many people possible the opportunity to use the system.
- I've invested well over 5K of my own money in the development and touring of this system. I do that gladly for the love of this sport, beyond a desire to help drive the sport forward and make contests run more efficiently I have -zero- motive in pushing this system. I have no desire for any compensation for this system (in fact, due to the inability to get refurbished iPod touches the last two systems I built were at a several hundred dollar loss to me, my 'price' is intended to make me break even on the cost of equipment.
- Unlike MasterScoring, I similarly ask for no compensation if the system is used at the NATS. In short, I have no dog in the hunt and I'm not pushing for anything, I have simply indicated my willingness

to burn 1.5 weeks of vacation to help the NATS to be successful if they choose to use the system for any portion of the contest and I leave that decision up to the ED's wisdom.

Personally, having analyzed 30 contests worth of scores before/after scribe use, I have seen the effect the system has on removing even conscious bias from the scoring, to me that means it should be ESPECIALLY used in a team selection year. Even if it didn't make judging bias much harder to pull off, the \*perception\* of fairness it creates is worth it's weight in gold.

[President] Where did we ever say we were recommending the scribe system at the NATS due to anything other than "IT IMPROVES JUDGING". There are no doubts that the use of the scribe helps the judge to do a better job, again, it improves judging! The most complained about section of our sport is the judging. I have been pretty active in judging at the NATS for the last 5 years and have seen some rather hard to explain things written down on score sheets. The process at the NATS isn't "fine", it was simply the best that has been available. We now have something that is better, let's use it. Judging is difficult. Anything that we can promote that improves it is a big win for the sport of pattern and is right in our mission statement.

This all came out because Scott felt uncomfortable with the section in the NSRCA NATS Guidelines that recommended the phase in of the use of the electronic scribe for the NATS. That document is now approved and at the AMA. We have been "recommending" the electronic scribe to the tune of \$500 to each district and the world hasn't ended. We are not forcing anyone to adopt the system. Per Anthony's point, contest attendance and the NSRCA recommending an electronic scribe system seem rather unrelated on the face of it. That being said, I do not see how improving the quality of judging and making the judging task easier can HURT contest attendance!

**D6 District Champ points formula for 2017:** 

The intent of this points system is to reward promotion of pattern locally by recognizing those that participate often and fly consistently well. The overall goal is to develop leaders, encourage new participation, and create a sense of fun and pride in our district.

Points are accumulated at a contest in Intermediate, Advanced, Masters, and FAI classes based on the position you finished in and how many people you beat. The Sportsman class will not be awarded a District Championship. Sportsman is an entry level class, and pilots are encouraged to move up to Intermediate upon completing a season or two.

- Your best 5 performances are counted and two contests can be out of district. The Nats will
  not be used for the point system, only for a tie breaker (It cannot be used as an out of
  District contest). Pilots are encouraged to compete in the Nats as their finish in the
  Nats will be the tie breaker.
- 2. NSRCA membership is required before contest results begin to count toward district

- championship points. (IE: To gain points, one must be an NSRCA member).
- 3. Points accumulation will end and the winners will be announced after the final contest of the season as listed on the Contest Calendar.
- 4. There will be no district championship meet that carries double points because we haven't solved the problem of making a single contest accessible to all, or a way of combining results of a collection of contests.
- 5. The pilot is responsible for delivering out-of-district results to the <u>scorekeeper</u> for contests they want counted. It will only count if he receives the final results for the entire class flown, not just your finishing place. Sorry, contests held outside of the continental U.S. may not be used.

1	7 + number people beat
2	5 + #people beat
3	3 + #people beat
4	2 + #people beat
5	1 + #people beat

### Ties will be broken in this way:

- 1. The pilot finishing highest in the Nationals. (If only one of the tied pilots attended the Nats, then he will be declared the winner). If neither attended the Nats then go to tie breaker #2.
- 2. The pilot who attended the most in-district contests during that season. If still tied go to tie breaker #3
- 3. Points winner at the last contest both pilots attended together. If this doesn't work, go to the previous head to head contest, until exhausted. If still tied go to tie breaker #4
- 4. The larger number of people (in the five counted contests) that the pilot beat.

## Discussion

**D6:** The reasoning behind the changes are as follows:

1.Taking the Nats out of the system as a point earner simplifies the scorekeepers job as the current rules only allow for a max points for the Nats based on the largest contest in D6, since the largest contest is normally well after the Nats, those points cannot be calculated until after the last contest of the season. We still use the Nats as a tie breaker so it still encourages attendance at the Nats since there are at least 3 contest in D6 after the Nats, one being the largest contest in

D6, and since we use the top 5 best finishes for the pilots this leaves more than half the possible points coming from contest after the Nats. Therefore no one can be sure they won't be tied at the end before Nats time.

2.Before, we allowed pilots to count points at contest they attended before they became NSRCA

members if they join by the first round at the Nats. The new rule requires NSRCA membership before earning points, and no previous contest will count for that pilot

prior to his joining. Encourages joining early, but doesn't leave out the pilots who join later as they will earn point for any remaining contest after they join.

3. Tie breakers have changed in that we would now use the Nats as the first tie breaker, and the flyoff has been eliminated as the last tie breaker as it was deemed impractical since by the time we go thru all the other tie breakers it will be days after the event anyway.

Secretary:

1. Eliminating point accumulation from the NATS discourages participation at the NATS



## **Discussion**:

## District Champ points formula for 2018:

The intent of this points system is to reward promotion of pattern locally by recognizing those that participate often and fly consistently well. The overall goal is to develop leaders, encourage new participation, and create a sense of fun and pride in our district.

Points are accumulated at a contest in Sportsman, Intermediate, Advanced, Masters, and FAI classes based on the position you finished in and how many people you beat.

- 1. Your best 5 performances are counted. Two out of district contests can be used to make up your best five. The Nats will be used for the point system as an in district contest. However, in the Nats you will only earn points for the number of pilots beat based on the largest number of contestants in your class at the D6 contest that has the largest number of pilots in that class in the previous year, plus the place points shown below.
  - (IE: If 20 in your class at the 2018 Nats, but only 10 in that class at the 2017 D6 contest with the largest number of pilots in that class, then placing first in that class at the Nats earns 7 point for placing first plus 9 point for the number of pilots beat.)
- NSRCA membership is required before contest results begin to count toward district championship points. (IE: To gain points, one must be an NSRCA member).
- 3. Points accumulation will end and the winners will be announced after the final contest of the season as listed on the Contest Calendar.
- 4. There will be no district championship meet that carries double points because we haven't solved the problem of making a single contest accessible to all, or a way of combining results of a collection of contests.
- 5. The pilot is responsible for delivering out-of-district results to the <u>scorekeeper</u> for contests they want counted. It will only count if he receives the final results for the entire class flown, not just your finishing place. Sorry, contests held outside of the continental U.S. may not be used.

## Ties will be broken in this way:

- 1. The pilot finishing highest in the Nationals. (If only one of the tied pilots attended the Nats, then he will be declared the winner). If neither attended the Nats then go to tie breaker #2.
- 2. The pilot who attended the most in-district contests during that season. If still tied go to tie breaker #3
- Points winner at the last contest both pilots attended together. If this doesn't work, go to the previous head to head contest, until exhausted. If still tied go to tie breaker #4
- 4. The larger number of people (in the five counted contests) that the pilot beat.


